## TO: THE VOTERS OF ENGLISH RIVER FIRST NATION ("ERFN")

A ratification vote of the voters of ERFN pursuant to the Voting Guidelines will be held during the week starting September 11, 2023 and ending September 15, 2023, to determine if the Voters of ERFN who are at least 18 years of age support ERFN entering into the Shared Prosperity Agreement with Denison Mines Corp.

The following question will be asked of the Voters of ERFN by secret ballot:

# As a Voter of ERFN, do you think English River First Nation should enter into the Shared Prosperity Agreement with Denison Mines Corp.?

Voters will have the opportunity to vote either in person, by mail-in ballot, or online. Only voters who specifically request a mail-in ballot and for whom Band Council has a current address will receive a mail-out package with information and with forms required to vote by mail-in ballot. The deadline to request a mail-in ballot package is August 31, 2023.

A List of Voters is posted with this notice. .

Any individual may apply to the Chief Ratification Officer at any time prior to 8:00pm (CST) on Friday September 15<sup>th</sup> to have the List of Voters revised if such member believes that:

- the name of a Voter does not appear on the List of Voters;
- the name of a Voter is incorrectly set out on the List of Voters; or
- the name of an individual who is not qualified to vote is included on the List of Voters.

Any individual may, up to and including the last day of the Voting Week, apply to the Chief Ratification Officer to have his or her name added to the List of Voters if that individual can provide evidence of eligibility to vote that satisfies the Chief Ratification Officer that:

(a) he or she is at least 18 years of age or will be at least 18 years of age by September 15, 2023, and

(b) he or she is eligible to be added to the list, maintained by the Department of Indigenous Services Canada, of individuals associated with ERFN whom the Department believes meet eligibility requirements in accordance with section 11 of the *Indian Act* (R.S.C., 1985, c. I-5).
